## **HOSTEL RULES & REGULATIONS**

Usually, student housing is a College-provided facility, hence **it cannot be considered a right**. The Management is free to approve or refuse a student access to the hostel without giving any justification at all.

### **1. ELIMINATION OF RAGGING:**

Although the College promotes open communication, harmonious living and working environments, and free interaction among students, any kind of ragging is prohibited. Any student seen engaging in ragging will be expelled from the hostel right away and face disciplinary action, which might lead to their expulsion from the institution as well. It should be mentioned that ragging, in any form, is now a crime under directions from the Honorable Supreme Court. The College administration is required by law to notify any instances of ragging to the police so that the authorities can take the proper legal action. The country's Supreme Court has ruled that it is illegal to rag any junior or new student.

The college's management wants its residents to think of the hostel as their place of residence. It requires all hostellers to act as they would in their own homes. In the Hostel or on campus, students from all over the nation live peacefully as sisters and brothers without any issues.

### **4. ADMISSION:**

By the deadline, students who wish to live in a hostel must submit an application using the (H-34) form, which has to be properly signed by their parents. Application forms that are not complete will be canceled.

Once the application is accepted in principle, the student will then approach the accounts office and deposit the required fee. Duly filled application form complete in all aspects should be submitted to the Warden.

Students already staying in the hostel do not get allotment for the next academic session unless an application is submitted for re-allotment on the prescribed application form (H-35).

**Note: Ex-students are not allowed to reside in the hostel.**

## **5. REGISTRATION:**

Only those applicants who have deposited the fee will be registered and names will be included in the seniority list which will be prepared based on the date of fee deposit. Existing hostellers who do not register themselves will lose their preference and treated as fresh applicants for allotment.

## **6. SENIORITY:**

Two seniority lists shall be maintained by the hostel committee.

### **Old/ Senior Students/ Residents:**

- **List 1:** Old students are required to reapply before the end of the current academic year. Registration will only be confirmed upon submission of the application along with full hostel fee payment in advance. Failure to deposit the fee within the specified timeframe may result in the allocation of hostel accommodations based on availability.
- **List 2:** New/ Fresh Students/ Applicants – As per admission.

## **7. CRITERIA TO BE FOLLOWED FOR HOSTEL ALLOTMENT:**

- The hostel will assign rooms based on the students' first come, first served.
- No requests for particular rooms will be taken into consideration.
- However, the request for a choice of roommate may be considered only after approval of the committee.
- Room once allotted shall not be changed for whatever reason it may be. The Hostel Management Committee has laid down the following criteria for the allotment of rooms.

### **NOTE: No hostel accommodation will be allotted to the following:**

- Students involved in indiscipline cases of any nature in the past.
- Students with Ex-student status.
- Students whose class attendance was below 75% while staying in the hostel during the preceding academic year.

## **Room Allotment Procedure:**

- Check room availability in the respective hostel warden's office & obtain an availability slip.
- Deposit the full fee in the accounts department and obtain a receipt. Submit the fee receipt to the warden's office to complete the allotment.

## **8. MEDICAL:**

- Students are compulsorily required to submit a medical certificate from a qualified registered Doctor. Students are also required to get vaccinated against Covid & Hepatitis B” and must submit a certificate at the time of admission.
- In case a hosteller becomes seriously ill, his/ her parents/ guardians are informed over the telephone. If required the student is taken to the Hospital by Ambulance, given treatment or hospitalized for immediate treatment. All expenditures incurred on medical treatment of the student will be borne by the parents.
- A Qualified Doctor timely remains available at the college’s medical room.

## **Code of Conduct:**

Hostellers will follow and strictly adhere to the rules prescribed by the Hostel Management Committee. Non-adherence to the rules will invite expulsion from the hostel without any fee refund.

## **Inventory Rule:**

Items issued to hostellers in the room shall be checked by the warden before the students vacate the rooms at the end of the year. Students shall be required to pay for any damages caused to the issued items or fixtures.

## **9. Instructions for Hostellers (Do’s):-**

- a) It is mandatory to submit an undertaking for anti-ragging and hostel rules at the time of applying for hostel allotment.
- b) Maintain strict discipline at all times and obey all written/ verbal instructions issued from time to time.

- c)** Read the notices on the notice boards daily and follow the instructions meticulously. Ignorance of orders/ instructions will not be accepted as an excuse.
- d)** Keep your rooms and surroundings clean.
- e)** Switch off the Lights, Fans, close windows & doors and lock the room before leaving.
- f)** Gate pass is a must while proceeding for home even when college closes for holidays/ semester breaks during academic days.
- g)** When leaving the hostel for a short period, kindly sign out in the register provided. Additionally, ensure to present your I-card at the college gate when entering or exiting the premises
- h)** Make an entry in the register kept with the Security personnel before proceeding to town on a visit or to your homes.
- i)** Return back to the hostel in time as notified from time to time.
- j)** Report to the Hostel Warden in case of self-sickness or any other hostel inmate.
- k)** Immediately report to Chief Warden/ Warden/ Security in case any damage to property is noticed.
- l)** Make use of the available facilities as per laid down timings strictly.
- m)** Follow the meal timings strictly as laid down from time to time.
- n)** Dispose of the waste in the dustbins only, provided for this purpose.
- o)** Ensure the safety of items/ equipment provided in the hostel or mess.
- p)** Introducing Automated Clothing Machines now accessible in all hostels, offering convenient mobile app payment options
- q)** Shall use bathroom or toilet fittings properly and shall not cause any damage to it.
- r)** Avoid wastage of water, and electricity and should close the water taps immediately after use.
- s)** Avoid wastage of food in the mess, take in small quantities any number of times as per requirement.
- t)** Proper dress code (casual dress) should be adhered to during their stay in the hostel after college hours by the inmates of both Boys' & Girls' Hostels.
- u)** Students will have to vacate their rooms within two days after their examinations are over.

- v) Students should carry their hostel identity cards while moving in/out to/from campus/ hostel.
- w) Students, if desired, may celebrate any function (Birthday etc.) in the dining hall between 4:30 pm to 5:30 p.m. (at tea time) or in the college canteen before 6 p.m. with the permission of the warden. In any case, students are not allowed to celebrate any function in their rooms.

#### **10. Instructions for Hostellers (Don'ts):-**

- a) Stay in the hostel rooms during classes / academic hours.
- b) Leave the hostel premises without permission.
- c) Use of a Heater, Immersion Rod, Electric Press, or any other electrical appliance of high current consumption is not allowed. If found using, the item will be confiscated and an applicable fine will be imposed.
- d) Take any visitor, relative, friend, outside student, or day scholar to the hostel.
- e) Bring any item of mess such as food, plate, tumbler or spoon to your room from the mess.
- f) Leave the room unlocked or unattended. **College authorities shall not be responsible for any losses.**
- g) Remove furniture or any other item from other rooms.
- h) Keep any valuables or cash in the room. **College authorities shall not be responsible for any losses.**
- i) Cook any type of meal in the room.
- j) Play loud music.
- k) Disturb other students in the hostel.
- l) Play cards or gamble or any other undesirable act in the room.
- m) Chewing of Pan, Tobacco, Gutka or smoking of Bidi/ Cigarettes in the hostel/ campus.
- n) Students are strictly forbidden from consuming alcohol, drugs, cigarettes, tobacco products, or any other intoxicants inside the campus or entering the campus after consuming the same. Any student found consuming such things or in a drunken state on campus will render himself/ herself liable for strict disciplinary action, including expulsion/ rustication from the Hostel/ College.
- o) Bring any food to the room from the mess unless permitted to do so in case of sickness etc.

- p)** Keep the computer in the room without written permission from the Director. College authorities shall not be responsible for any loss or damage even if permission is granted.
- q)** Get involved in the ragging of freshers or other students. Defaulters shall invite disciplinary action including expulsion from the hostel/college without any fee refund. Ragging is an offense and punishable in accordance with the ruling of the country's Apex Court.
- r)** Students are strictly forbidden to keep any kind of firearms (even if it is a licensed one), fireworks, or weapons (knives, etc.) in the campus.
- s)** Play Holi with color, water, or mud and burst crackers in the hostel premises during Holi & Diwali respectively.
- t)** Park the two-wheelers in the Hostel Campus without necessary permission.
- u)** Allow or permit day scholars inside their rooms.
- v)** Students of the opposite sex are NOT permitted to enter the Hostel/ Mess.
- w)** Misuse of electricity by the hosteller will be fined as per applicable charges.

**11. Rule for Out Pass:**

Every hosteller must seek the Warden/ Chief Warden's permission in the form of an Out Pass / Leave Form for leaving the campus hostel during the period when the college is functioning. Out Pass / Leave Form must be shown to the Security Staff while going out or returning to the campus. Hostellers must follow the below timings for signing the Out Passes / Leave Forms:

## 12. Hostel Attendance Timings:

9:00 p.m. to 10:00 p.m. (I Year) & 09:30 p.m. to 10:30 p.m. (2<sup>nd</sup> Year & above) during winters & 09:30 p.m. to 10:30 p.m. (I Year & above) during summers or as notified by the Chief Warden.

### Girl's Hostel:

6:30 p.m. to 07:00 p.m. during winter & 06:30 p.m. to 07:00 p.m. during summer or as notified by the Chief Warden.

**Important Note:** -After college and hostel attendance timings no one is allowed to leave the hostel premises without taking prior permission from the warden followed by gate pass entry at the hostel and college registers maintained by the college guards. If any student does not do so, he/she will be held responsible for any mishappening.

### **Expulsion from the Hostel & Mess:**

In case the college authorities are of the opinion that the conduct of any student is not up to the mark as expected, the student shall be immediately expelled from the hostel without any fee refund and disciplinary action will be initiated.

### **14. Hostel Mess Rules:**

The Mess facility for students is managed by the Mess Contractor in collaboration with the Mess Committee, consisting of hosteller students. The Mess Committee oversees the quality of food served, and the menu selection, and ensures hygienic standards. The college facilitates payments to the Mess Contractor on behalf of hosteller students.

**Breakfast, Lunch, Evening Tea & Snacks, and Dinner will be provided in the mess at the stipulated time.** The mess will be closed during Holi / Diwali Holidays & Summer/ Winter vacations and **NO REFUNDS ARE PERMISSIBLE.**

### **The following norms shall be strictly adhered to:-**

- 1) No utensils/food is allowed to be taken outside the mess. Defaulters will be fined Rs. 500/-.
- 2) If any Hostler allows a day scholar to stay in his room, he will be fined Rs. 1000/- & his allotment will be canceled. The concerned day scholar will also be fined Rs. 1000/-.
- 3) Drinking liquor on the hostel campus is strictly prohibited. Anyone found indulging in drinking will be expelled from the hostel along with a fine of Rs. 5000/-. He may also be expelled/ rusticated from college after a proper inquiry by SIC.
- 4) No mess-offs are allowed for whatsoever reason it may be.
- 5) Students will maintain discipline at meal timings and follow the mess manners.
- 6) Students shall form and follow a queue at the food counters.
- 7) Hostlers are expected to follow table manners.
- 8) Students are not allowed to enter the kitchen/ cooking areas.
- 9) Students will not get into an argument with mess staff/contractors for any reason whatsoever.
- 10) Complaints if any are to be reported to the Warden/ Chief Warden.

The hostel is meant to be a home away from home for students. The inmates of the hostel are expected to be mutually friendly and co-operative with their fellow students, guests and visitors. They shall maintain proper discipline; observe hostel and mess rules and timings enforced from time to time.

**Eradication of Ragging:** Ragging is Strictly Prohibited. Ragging in any form i.e. making unpleasant noise, disorderly conduct, doing any act which causes or likely to cause physical or psychological harm or raise apprehension or fear of shame or an embarrassment to the new student whether by words, spoken or written or by an act which include teasing, abusing, playing practical jokes on or causing hurt to such students or asking the new student to do any act or to perform such things which such student will not be in the ordinary course, willing to do is strictly forbidden. If anyone is found guilty of directly/indirectly involved or abetting in ragging he/she will be punished/rusticated/ expelled/suspended from the institute and also liable to prosecution in terms of the Supreme Court of India decision on Writ Petition No. (C) 656/1998. Ragging is now a crime. No one can feign ignorance of the law. Under the prohibition of ragging Act 1997 those who indulge in ragging can be punished with a Jail term of six months to 10 years & fine up to Rs. 50,000/-

A student seeking admission to the hostel shall have to submit another affidavit along with her/his application for hostel accommodation that she/he is aware of the ragging law in this regard and agrees to abide by the punishment meted out if he/she is found guilty of ragging and/or abetting ragging. (AICTE Requirement)

## 17. FORMALITIES TO BE COMPLETED BEFORE JOINING THE HOSTEL

- 1) To avail of hostel accommodation, a student (fresher) has to register his/her name in the hostel by applying the prescribed format. The following documents are required to be submitted along with the application:-
  - a. Declaration by the parents
  - b. Anti-ragging affidavit by self & parents.
  - c. Latest photographs of self, father, mother and the Local Guardians (not older than 6 months).
- 2) To continue in the hostel in 2<sup>nd</sup> and subsequent years (re-admission), students have to submit separate applications in the prescribed format along with a declaration & Anti-ragging affidavit by self & parents.
- 3) An authority letter from the parent, indicating two names and addresses (with their photographs and telephone numbers), who would act as the local guardians. ***Please note that only those persons who are employed and live in a family environment will be allowed to become local guardians. No student will be allowed to become a local guardian of another student. These rules will be strictly adhered to by the Hostel Wardens.***
- 4) A certificate from the local guardians stating to accept the responsibility for the hosteller student and permitting the student to stay with him/her during sickness must be signed by the student and his/her parents as well.

- 5) Parents' contact numbers are to be available in the hostel to contact them in case of any emergency or any other requirement. Any change in contact number should be informed without any delay to the Hostel Wardens.

## **18. ADMISSION:**

New students taking admission in the first year shall be allotted hostel accommodation on a first come first serve basis.

For allotment of hostel accommodation for old students, a merit list will be prepared with the following criteria. (a)% of class attendance in the college

- a. % of attendance in the hostel
- b. % of marks in odd semester
- c. Degree of involvement in indiscipline activities, if any

Students shall be given preference to get the hostel room as per his/her choice according to merit

### **NOTE: *No hostel accommodation will be allotted to the following:***

- 1) Students involved in severe indiscipline cases of any nature in the past. In case of failure and/or detained in the previous year.
- 2) Generally, hostel allotment is done for a period of 10 months from August to May, however, under certain unavoidable circumstances this period may get shifted but the duration shall remain 10 months only. Hostel shall be allotted on payment of full fee, once allotment is done, no change of room or cancellation is permitted, in emergency cases if the hostel is vacated by any student, only messing and laundry charges shall be refunded, also no refund is made in case any student is asked to vacate the hostel on disciplinary grounds.
- 3) All the Hostellers should always carry their valid Identity Cards issued by the Institute while exiting/entering the Hostel / Campus (Showing the I- Card image in Mobile is invalid).
- 4) Residents of both Boys' & Girls' Hostels shall not go out of Hostels in shorts during college hours.
- 5) Hostel rooms are equipped with furniture and fittings of appliances. Students occupying the room will sign for the receipt of items in the Inventory Register. She/he will be responsible for handing over the items in their original

serviceable condition to hostel authorities while leaving the rooms at the close of the academic session.

- 6)** Rough handling of dining hall furniture, room furniture, or any furniture/property or fittings of the hostel is strictly forbidden. If any individual or group is identified to have caused the damage, double the cost of the damaged property will be recovered from her/him/group. Repeated acts of causing loss to the hostel property will result in expulsion from the hostel.
- 7)** In case of damage to the College or Hostel Property in common areas if the actual student is not identified then all the students staying in the area shall have to bear double the cost of damage.
- 8)** The hostellers themselves are personally responsible for safeguarding their belongings. They are advised not to keep large amounts of cash or valuables like gold rings, costly wristwatches, etc., in their rooms. They should also take care of their wallets, Calculators, Cell Phones, Laptops, Computers, and Books. In case of theft, damage, or loss of any item, the hostel authorities/institute will not be responsible in any way. The hostellers are advised to keep their rooms, boxes, suitcases, cupboards, etc., securely locked with good-quality locks.
- 9)** The hostellers are neither allowed to keep private electrical equipment nor tamper with electrical fittings provided in rooms. Unauthorized possession will lead to confiscation of the goods.
- 10)** Smoking, gambling in any form such as Playing Cards (even without money at stake), consumption of alcohol, use of drugs and narcotics and even possession of such things are prohibited. Anyone found indulging in the use of such things will not only be asked to vacate the hostel but also be rusticated from the institute.
- 11)** The institute timings are 9.00 am to 4.50 pm. Students are not allowed to stay in the hostel during class hours unless the stay is unavoidable due to illness or any other valid reason. In such cases, they should obtain the permission of the HOD/Dean/Director and communicate the information to the Warden in writing.
- 12)** Inmates of the Hostel can use their personal desert coolers by submitting the undertaking and paying the applicable charges.

13) Use of any electrical appliances except table lamp and mobile charger, is prohibited.

14) Lights and Fans should be switched off when no one is there in the room, also room lights shall remain off between 11:00 p.m. to 05:00 a.m., however, if any student wants to study late hours, he/she can do so during the study room or use table lamp. The power supply shall not be available during class hours.

### **19. MESS:**

It is mandatory for students residing in the Hostel to join the mess attached to the hostel. Hostellers are required to dine in the dining hall. No hosteller is permitted to take food in the room except for those reported sick with prior permission of the hostel warden. Indoor cooking including making of tea/coffee/noodles in the rooms is strictly prohibited. The hostellers shall not waste food, electricity & water.

**Wastage of food is a national loss.**

1) Students, if desire, may celebrate any function (Birthday etc.) in the dining hall between 4.30 p.m. to 5.30 p.m. (at tea time) or in the college canteen before 6 p.m. Under any circumstances, students will not celebrate any function in their rooms.

2) If a hosteller needs to stay out/leave the hostel after night roll call due to any reason, he/she has to obtain prior written permission from the Warden with a

request from the parent for the same, also if a hosteller wants to leave the hostel on class days (Monday to Friday), prior written permission of department HOD must be obtained. In any case leaving the hostel without obtaining prior written permission shall lead to disciplinary action including Fine & Expulsion from the hostel without any fee refund.

## **20. ATTENDANCE:**

All students will report for the Roll Call every day as per prescribed timings by the Wardens. The roll call timings shall be as below:

**Girls Hostel:** 7:00 PM -7:30 PM (summers) & 6:00 PM – 6.30 PM (winters)

**Boys Hostel:** 09:00 PM-9:30 PM (for 1<sup>st</sup>year students) & 09:30 PM – 10:00PM (for 2<sup>nd</sup> year & above) during winters & 09:00 p.m. to 10:00 p.m. (I Year & above) during summers or as notified by the Chief Warden as per the season/circumstances.

**The last in-time of the Girls Hostel is 6:30 PM (winters) and 7:00 PM (summers).**

**The last in-time of the Boys Hostel is 9:00 PM (winters) and 9:30 PM (summers).**

- 1) No student shall remain absent from the hostel during the night unless she/he has obtained a night-out pass from the hostel warden. Night-out permission to hostellers will be given on weekends only if the request of the inmate has the prior approval of the parents.
- 2) While going out of the Hostel for any work or on leave the students' should make an entry in the daily in-out register or leave register kept at the Hostel Guard Room in his/her handwriting and carry I Card along.
- 3) If any hosteller leaves the hostel without prior permission or remains absent continuously for more than a month, he/she will automatically forfeit the right to stay in a hostel.
- 4) Students are required to attend weddings, and other social functions, and going outstation will require permission from the hostel Wardens, subject to receipt of a written request for the same from parents of the student.
- 5) All students shall compulsorily proceed on leave during Holi, Diwali & Semester Breaks as per the academic calendar, no student shall be allowed to stay in Hostel during this period. Students should close all

doors/windows and switch off the lights/fans in their rooms before leaving for home.

- 6)** Students having any Chronic/Communicable disease are not allowed to stay in a hostel. Hostellers falling sick or feeling symptoms of sickness should report to the hostel warden for transportation to the hospital. 24-hour Ambulance Service is available on the campus.
- 7)** Parents/Guardians/Visitors can meet their ward in the visitor's room with the permission of the hostel warden before 7.00 pm. No Parent/Guardian/Visitor is allowed to stay or visit students in their living rooms.
- 8)** Discussion on politics and religion is forbidden in the hostel & mess.
- 9)** No notice will be displayed by hostel inmates in the hostel notice board without the countersignature of the hostel warden.
- 10)** Taking part directly/indirectly in any movement or agitation or strike of students in the institute for any reason whatsoever will attract punishment, rustication or expulsion, which in the opinion of the Management/Director is subversive to the discipline of the institute.
- 11)** The Institute/Hostel authorities will conduct surprise checks periodically and if anyone is found violating the above rules, disciplinary action will be taken against them. The hostel rooms are subject to inspection by the Institute/Hostel authorities to make sure that they are kept neat and tidy and no unauthorized items like liquor, drugs, lethal weapons and other banned items etc., are kept in the room.
- 12)** Day scholar students are not allowed to enter the hostels, also hosteller students are not allowed to visit each other's rooms.
- 13)** Hostellers are advised to keep a minimum amount of cash with them to avoid theft. They can make use of the ATM facilities at the time of needs.
- 14)** Hostel authorities do not take any responsibility, legal or financial, for any injury caused to a boarder in any accidental mishap.
- 15)** Parents are advised to keep in constant touch with Institute/Hostel authorities regarding the performances of their wards and advise them to be sincere in their studies. Indiscipline of any kind including quarreling & fighting etc. in the hostel premises will be penalized. Habitual offenders of

fighting & quarreling will be expelled from the hostel without a refund of hostel charges.

- 16) Parents shall be responsible for any act of indiscipline by their ward and shall extend full cooperation to college authorities for correction of their ward including fine, punishment, and expulsion from the hostel. Hostel Staff can communicate with the parents to report any issue concerning their ward.
- 17) Hostel allotment is provisional, the hostel management committee reserves the right to change the room or cancel the allotment without any prior notification by refunding the hostel charges on a prorate basis.
- 18) College authorities can change or modify the hostel rules by notifying such changes.
- 19) Above mentioned rules have come into force with effect from 01.05.2024.

*In addition to the above, if my ward is found violating college/hostel rules, or involved in any ragging or indiscipline activities, then the college or government authorities may take any disciplinary action including expulsion/rustication from the hostel/college (without refund of any fee) as they may feel appropriate and that will be binding to me.*

### **(a) Terms of reference**

- (i) Supreme Court Orders
- (ii) UGC Regulations and Guidelines

### **(b) Prohibition of Ragging**

- (iii) Ragging within the College Campus including its Institutions/ Departments and hostel is strictly prohibited.
- (iv) Ragging in any form is also prohibited in the private lodges/ buildings where college students are staying.
- (v) Ragging in any form is prohibited in the hostel mess, Canteen, Cafeteria & Transport.
- (vi) No person including students /Staff/Faculty shall participate or abet or propagate ragging in any form.

## **2. Punishment**

Ragging is a cognizable offence under the law and the punishment to be meted out has to be exemplary and justifiably harsh to act as a deterrent. It may include one or more of the following: -

- Cancellation of admission, suspension, rustication or expulsion from the university hostel.
- FIR with the police and arrest.
- Collective punishment may be imposed where involved persons are not identified.

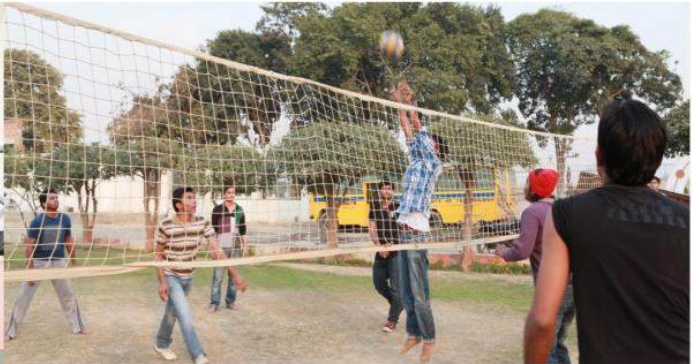
