Minutes of IQAC Meeting (12th) held on February 24, 2024 in HRD Room

An IQAC meeting (12th) was conducted on February 24, 2024 in HRD Room wef 11:00 am. The agenda of this meeting and attendees is attached herewith.

The outline of the discussions held / outcome of the meeting are mentioned hereunder :

1. The report of Internal Audit (session 2023-24, Odd Sem) of various departments conducted by IQAC through respective Deans during Jan-Feb, 2024 was shown. Its observation / key recommendations are attached herewith.
2. The procedures / formats pertaining to Curriculum Planning, Academic Monitoring, Academic Data and OBE related formats (including OBE-08), as attached herewith, were approved with the consent of all concerned. These are to be used for regular record-keeping / academic monitoring purposes.
3. There is no updating in the assessment tools, attainment levels, pattern of question paper and quality of question papers and assignments (internal assessment) etc. Hence, ongoing adopted procedures are to be followed. However, dept may update these with the approval of DQAC concerned.
4. All the HODs were requested for :
 - a. Framing / Reviewing / Updating / CO-PO-PSO Mapping of 2023-24 Session (i.e. II / III / IV Year of 2023-24; as per OBE-03) and its submission to IQAC with display at MIET Website.
 - b. CO-PO/PSO Mapping of batch passing out in 2023-24 (as per OBE-04; including I / II / III / IV year of 2020-2024 batch) and its submission to IQAC with display at MIET Website.
 - c. CO-PO/PSO Attainment of batch passed-out in 2022-23 with Observations and Measures to be taken (OBE-07 with OBE-05/06) and its submission to IQAC
5. Analysis of various feedbacks (submitted by concerned stake-holders) with Measures # Odd Sem : 2023-24 was shown and was approved by IQAC.
6. Work related to mentor – mentee and weak and bright students (Identification Criteria, List and Measures to be taken) – as per C-01 and C-02; was discussed and approved by IQAC for further compliance.
7. As result has not been yet declared by AKTU, so Result Analysis of batch passing out in 2023-24 (Odd Sem) is not available.
8. The Curriculum Gap (as obtained from HODs) were communicated to AKTU (email dated August 10, 2023) by the Director.
9. IQAC shared the approved Curriculum Planning (including academics) and Academic Measures – 2023-24 (Odd and Even Sem, both) for further compliance.
10. Checklists for Course File Preparation and Review at Dept Level (2023-24, Odd and Even Sem) was shared and approved for further compliance at department level.
11. The shown Annual Report Data was approved by IQAC.

12. Progress Report / Compliance of Strategic Plan was shown in IQAC and everyone found it satisfactory.
13. Course files are to be prepared as per prescribed checklist (attached herewith). The quality of contents is to be reviewed at department level through respective DQAC.
14. All the HODs were requested to take-care of all the measures to fill the identified curriculum gap, to improve the academic performance of the students concerned and to ensure conduct of activities / events / trainings / seminar / workshop / expert lecture / industrial visit / internship / skill learning / delivery of content beyond syllabus, value added courses / multi-disciplinary projects / projects and/or courses related to IKS etc. Further, take all suitable measures as per the observations of PO-PSO attainment and actions to be taken (keeping / maintaining all the records concerned at department level).

The meeting was adjourned at 12:30 pm with thanks to everyone. The minutes of meeting are prepared and approved by undersigned.
