The program has been granted accreditation for 3 years. **Meerut Institute of Engineering & Technology, NH-58, Bypass Road, Baghpat Crossing, Meerut- 250 005, Uttar Pradesh** should submit fresh online application through eNBA portal not before five months from the expiry of validity of accreditation mentioned above.
